SECURE

ACT (Setting <u>Every</u> **Community** Up for <u>Retirement Enhancement Act of 2019</u>) was signed into by Donald Trump on December 20, 2019. As with most revenue acts that propose to provide benefits, the SECURE Act took away many tools to delay tax on the distributions from deferred retirement accounts. Prior to tax the SECURE Act, retirement accounts could more easily be transferred to future generations on a tax deferred basis with careful planning. After the enactment of the SECURE Act, almost all of those planning opportunities were lost.

A second version of the **SECURE Act**, nicknamed the **SECURE Act 2.0**, was signed into law on December 29, 2022. These provisions were intended to improve and clarify the **SECURE Act**. These changes are...
