

Seller Beware... Recent Tax Case Compels Review of Corporate and Company Buy-Sell Agreements by John M. Goralka, Esq.

A Buy-Sell Agreement is a key component of business succession planning, particularly for small businesses with two (2) or more family groups in the ownership structure.



This issue is applicable for both Corporations and Limited Liability Companies ("LLCs"). A Buy-Sell Agreement provides for the possible or mandatory buyout

of an owner's interest in the business upon the occurrence of certain stated events such as death, disability, termination of employment and divorce. Often these agreements are funded at least in part by life insurance or disability insurance.

Buy-Sell Agreements are needed to plan for the occurrence of these critical events which may place the businesses' continued success and survival at risk. In a two partner/owner business, the surviving partner would rarely wish to be partners with the deceased partner's spouse or children. The surviving business owner may have to hire additional staff to cover the work done by the deceased partner. The surviving partner may be less enthusiastic about sharing ownership, decisions, control and profits with a passive, non-working partner. The deceased partner's spouse and children often do not work in the business. The deceased partner's family needs cash to take the place of the lost income from the deceased partner.

The properly drafted Buy-Sell Agreement can solve all of these problems, particularly if...

The late Queen of Soul's discovered notes had to meet certain Michigan requirements to be considered a valid will. The outcome might have been different in other states.



Aretha Franklin was known as the Queen of Soul. She will be forever remembered for her musical legacy, which includes "(You Make Me Feel Like) A Natural Woman," "Respect," "I Say a Little Prayer" and "Chain of Fools." She died in 2018 at the age of 76 from pancreatic cancer.

Franklin's entertainment attorney for almost 30 years, Don Wilson, indicated that Franklin was "a very private person who did not want to share private information" with others, including an attorney, which is why she would write her wishes and estate plan informally by herself.

Franklin prepared a 2010 will that was securely maintained. The 2010 will was discovered in a locked cabinet in her home. That will was not formally typed, but it was written in her own hand. This type of handwritten will is referred to as...

RECIPE OF THE MONTH

Grilled Sea Scallops with Parsley-Shallot-Honey Sauce

This sweet, delicate nibble is perfect for a seaside picnic.

With several more weeks of summer ahead I thought you might enjoy this dish as you think about a visit to the sea or just about anywhere you find a body of water you like. Even poolside!

<u>MAKES</u>: 4-6 Servings <u>PREP TIME</u>: 25 minutes <u>TOTAL TIME</u>: 30 minutes

INGREDIENTS

- Canola oil, for grill grates
- 1 tbsp. chopped shallot
- 1 lemon, peeled and chopped, plus 2
- teaspoons juice
- 7 tsp. pure honey
- Kosher salt and freshly ground black pepper
- 1/4 cup chopped fresh flat-leaf parsley
- 2 tsp. chopped fresh thyme
- 1/4 cup plus 1 tablespoon olive ail, divided
- 16 large sea scallops, muscle discarded

DIRECTIONS

- 1. Set up the grill for direct cooking and heat to medium-high.
- 2. Once hot, clean and oil grill grates.
- 3. Combine shallot, chopped lemon & juice, and honey in a bowl; stir until honey is dissolved.
- 4. Season with salt and pepper.
- 5. Let stand for 5 minutes.
- 6. Add parsley, thyme, and 1/4 cup olive oil.
- 7. Drizzle scallops with remaining tablespoon olive oil and season with salt and pepper.
- 8. Grill scallops, turning occasionally, until cooked through, 4 to 6 minutes.
- 9. Serve with sauce.


