Take It From a Tax Attorney: This Is a Magic Multimillion-Dollar Tax-Saving Strategy

The qualified small business 1202 stock exemption is a \$10 million exclusion that seems too good to be true and is often overlooked.



Magic numbers do exist: 1202 is a magic number for those involved in start-ups and similar business activities that involve the sale of highly appreciated stock. It can magically erase millions in taxes for certain people.

Internal Revenue Code (IRC) Section 1202 provides an income tax exemption in an amount equal to the greater of \$10 million or 10 times the adjusted basis of qualifying stock. The exempt amount is determined per taxpayer holding the stock sold.

Above all, you should choose someone you trust, keeping in mind that acting as a trustee or executor can be a complex, thankless and sometimes long-term job.




Perhaps the most important decision that you can make is the selection of the person to oversee your financial affairs if you are unable to do so. This person is the successor trustee of your trust, the executor in your will and the designated attorney-in-fact in your power of attorney. We will refer to all of these people as the successor trustee in this article. This selection is particularly important when, as is usually the case, the successor trustee may hold broad discretionary powers. Legal title to assets is actually vested in the trustee's name on behalf of the trust. The trustee manages the trust on behalf of the beneficiaries to carry out the grantor's purposes for establishing...

RECIPE OF THE MONTH Seared Tuna Steaks with Dill Aioli

Few dishes capture the essence of summer quite like seared tuna steaks. Quick to prepare, rich in flavor, and effortlessly refined. This recipe pairs the clean, meaty texture of fresh tuna with a bright, herbaceous dill aioli that's as versatile as it is delicious. Whether served straight off the grill or chilled for a patio dinner, these steaks offer a restaurant-quality experience with minimal fuss. Perfect for warm evenings and easy entertaining, this dish is a celebration of simplicity done right.

Total Time: 50 minutes

Prep Time: 25 minutesCook Time: 25 minutes

Servings: 4

INGREDIENTS

For the Tuna

- 4 fresh tuna steaks, each about 2 inches thick
- 2 tablespoon olive oil, plus more for brushing the grill
- Coarsely ground black pepper
- Sea salt

For the Dill Aioli

- · Leaves from 10 sprigs of dill, minced
- Leaves from 10 sprigs of parsley, minced
- Juice from 1/4 small lemon
- 1 garlic clove, minced
- 3/4 cup olive oil
- Sea salt

INSTRUCTIONS

- 1. Rub the tuna steaks with the olive oil and season with black pepper and sea salt. Let rest at room temperature while you prepare the grill.
- 2. Bring your gas or charcoal grill to high heat.
- 3. While waiting for the grill to heat up, combine the dill, parsley, lemon juice, and garlic clove in a small bowl and whisk together. While whisking, slowly incorporate the olive oil and season with sea salt. Set aside or chill in the refrigerator. If you want a lighter aioli, combine the initial ingredients in a blender and then slowly add the olive oil.
- 4. Once the grill is ready, at about 450°F with the coals lightly covered with ash, brush the grate with a little olive oil. Tuna steaks should always be cooked between rare and medium-rare; anything more will be tough and dry. To accomplish a perfect searing, place the tuna steaks directly over the hottest part of the grill and sear for about 2 minutes per side. The tuna should be raw in the middle (cook 2 ½ to 3 minutes per side for medium-rare).



5. Transfer the tuna steaks to a large cutting board and let rest for 5 to 10 minutes. Slice against the grain and then serve with the Dill Aioli on the side.
