



Nine Lessons to Be Learned From the Hilton Family Trust Contest

Disclaimers, good communication, post-marital agreements and more could help avoid conflict in a family after the owners of a wealthy estate pass away.



This article discusses the contest of Barron Hilton's family trust, which centers on changes made by Barron Hilton after the death of his wife, Marilyn. Barron gave 97% of his estate to charity, leaving only 3% to his children and family. While the Hilton family's wealth is beyond our imagination, there are lessons that we can all learn from the steps Barron took to minimize the potential that his family would contest or challenge his wishes. Details from their estate plan may be applicable to us all.

Background on the Hilton family

William Barron Hilton and Marilyn Hilton had eight children. Barron became the CEO and president of Hilton Hotels Corporation in 1966. He ran Hilton Hotels until 1996. Barron was very successful. He established the Los Angeles Chargers and formed the Carte Blanche Credit Card Company.

Marilyn Hilton died on March 12, 2004. Barron and Marilyn's estate plan included a marital trust. Many estate plans include subtrusts that spring into existence upon the death of the first spouse to die. A very common structure is an ABC subtrust format that...

How to Choose Your Trustee or Executor of Your Will

Above all, you should choose someone you trust, keeping in mind that acting as a trustee or executor can be a complex, thankless and sometimes long-term job.



Perhaps the most important decision that you can make is the selection of the person to oversee your financial affairs if you are unable to do so. This person is the successor trustee of your trust, the executor in your will and the designated attorney-in-fact in your power of attorney. We will refer to all of these people as the successor trustee in this article. This selection is particularly important when, as is usually the case, the successor trustee may hold broad discretionary powers. Legal title to assets is actually vested in the trustee's name on behalf of the trust. The trustee manages the trust on behalf of the beneficiaries to carry out the grantor's purposes for establishing the trust.

Trustee duties

The trustee's duties may change based upon the properties held by the trust. For example...

RECIPE OF THE MONTH Grilled Marinated Ribeyes

The ribeye, often hailed as the "king of steaks," is a prized cut of beef enjoyed for its exceptional tenderness, juicy flavor, and beautiful marbling.

Cut from the primal rib section – the same area that yields the coveted prime rib roast – rib-eye steaks offer a truly decadent steakhouse experience.

Total Time: 10 minutes prep; 4 hours marinating; 10 minutes grilling



Servings: 4

INGREDIENTS

- 1/2 cup barbecue sauce
- 3 tablespoons Worcestershire sauce
- 3 tablespoons olive oil
- 2 tablespoons steak sauce
- 1 tablespoon red wine vinegar
- 1 tablespoon reduced-sodium soy sauce
- · 2 teaspoons steak seasoning
- 1 teaspoon hot pepper sauce
- 1 garlic clove, minced
- 4 beef ribeye steaks (8 ounces each)

DIRECTIONS

- 1. In a large resealable plastic bag, mix the first nine ingredients.
- 2. Add steaks; seal bag and turn to coat. Refrigerate 4 hours or overnight.
- 3. Drain steaks, discarding marinade.
- 4. Grill steaks, covered, over medium heat until meat reaches desired doneness (for medium-rare, a thermometer should read 145°; medium, 160°), 5-7 minutes per side.


